Please be informed that as per Third Supreme Council Board Meeting, the forthcoming 20<sup>th</sup> International Assembly and Conference (IAC) was approved to be held at the Heritage City of Vigan (Ilocos Sur, Philippines) on 19 to 22 February 2015.

The registration fee per person, both KR member and member of any counterpart organization, is P5,000.00 for local chapters or \$250.00 for overseas chapters. This fee shall include round trip transportation (by land) to and from Vigan City, meals and snacks, assembly kit, materials and Ilocos Tour. As an option, commercial flights to and from Laoag City is available through Philippine Airlines and Cebu Pacific at the personal expense of the member/affiliate.
