
### **Fraternal Greetings!**

In our desire to achieve the KoR objectives, goals and to propagate the ideals of our national hero, Dr. Jose Rizal and to boost the effective and efficient performance of our members, the Supreme Council in its regular board meeting of 12 November 2016 has approved the following new policies for implementation and dissemination within your Chapter, Area and Region, to take effect immediately.

1. Submission to the Supreme Commander of Letter of Intent indicating the standard program to be followed in all Assemblies and knighthood ceremonies at least two-months prior to the suggested date for Supreme Council approval.
2. The program should include the following:
  - Courtesy call on the highest local executive officer in the City/Municipality/Province or in Philippine Embassies of each country where there is a Knight of Rizal chapter;
  - Parade to the Rizal Monument by KoR
  - A floral offering ceremony at the local Rizal Monument
  - to be followed by a tribute to our national hero, Dr. Jose Rizal;
  - Plans and programs of the Chapter/ Area/ Region;
  - Discussion of problems, solutions and resolutions; and
  - Knighthood and awarding ceremonies using Memorandum No. 11 as basis on the submission of prospective postulants, promotions of ranks and awards, creation of new Chapters with proper endorsement by the Chapter, Area and Regional Commanders.
3. Payment of applicable fees for knighthood and promotions. Payment of annual membership fees for each year pursuant to Amended By-Laws under Article IV, Section 4.b.
4. Submission of semi or annual report of activities to the Supreme Commander of all appointed Officers.
